Requirements:

A Ph.D. in food science or related discipline is required for this position. Applicants are not required to have a prior background in food science, although relevant teaching, postdoctoral, and/or industry experience would be viewed favorably.

A successful candidate will demonstrate strong potential for excellence in research, teaching, and service to the department/university/discipline. It is expected that the candidate will develop an internationally recognized and externally funded research program. Teaching responsibilities will include an undergraduate course in food processing (FS561), as well as another undergraduate or

graduate course in an area of interest. Service in supporting the missions of the undergraduate and graduate program is also expected.
